The investment objective of the Fund is to seek long term capital appreciation by investing primarily in the equity securities of issuers based in the United States.

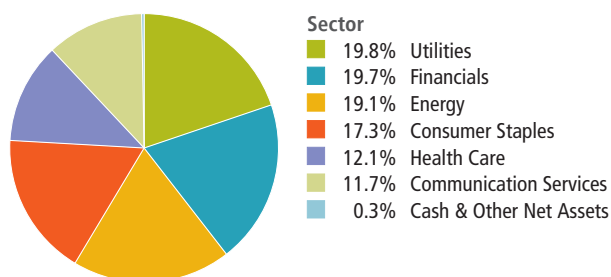
The charts below give you a snapshot of the Fund's investments on March 31, 2026. The Fund's investments will change.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Bridgehouse has rated the volatility of this Fund as **Medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this Fund does not have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how Series IH units of the Fund have performed since inception. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This section tells you how Series IH units of the Fund have performed in past calendar years. However, this information is not available because the Series has not completed a calendar year.

Best and worst 3-month returns

This section shows the best and worst returns for Series IH units of the Fund in a 3 month period. However, this information is not available because the Series has not yet completed a calendar year.

Average return

If you invested \$1,000 in the Series IH units of this Fund on the day the Series was established it would be worth \$912 as of March 31, 2026. This represents an annual compound rate of return of -7.9%.

Who is this fund for?

- This Fund is suitable for investors who are long term investors and who wish to add the appreciation potential of U.S. companies to their portfolio.
- The Hedged Series of units of the Fund is suitable if you wish to minimize exposure to fluctuations in the U.S. dollar relative to the Canadian dollar.
- This Fund is not suitable as a short term investment or for an investor who cannot tolerate a medium degree of volatility.
- This Series of units is generally for large investors with necessary minimum investments.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, any fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series IH units of the Fund. The fees and expenses - including any commissions - can vary among each series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

No sales and management fees are charged in respect of this Series of units.

2. Fund expenses

There are no Fund expenses directly charged to the Fund in respect of Series IH units, other than the Fund's trading expenses. Because this Series is new, its trading costs are not yet available.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Series IH Fee	Fees are negotiated with Bridgehouse and paid directly to us, and will not exceed 1.25%. This Series of units are generally for large investors with necessary minimum investments.
NSF Cheque Fee	A fee of \$25 may be charged on NSF cheques.
Short-term Trading Fee	Bridgehouse reserves the right to charge a short-term trading fee of up to 5% of the NAV of any units you sell or switch within 30 days of purchase in addition to any switch or redemption fees that may apply in order to deter inappropriate and excessive short-term trading that is harmful to the Fund.
Switch Fees	A maximum of 2% of the amount being switched may be charged and paid to your representative's firm to provide compensation for the time, advice and processing costs involved in a switch. All switch fees are negotiable with your representative.
Wire Transfer Fee	A fee of \$25 may be charged if you request a wire transfer.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
